| Title | MEMBERSHIP OF COMMITTEES AND PANELS |

## 1. PURPOSE/SUMMARY

To reassign seats on committees in line with political proportionality.

## 2. KEY ISSUES

- Following the recent resignation of Councillor Skoulding from the Fenland First Independent Alliance, this group ceased to have sufficient members to be considered a Group under the Local Government and Housing Act 1989.
- Councillor Archer has now joined the Liberal Democrat Group; the new group is called the Lib Dem Alliance with a total membership of 3.
- Accordingly the political proportionality of committees must be reassessed.


## 3. RECOMMENDATION(S)

1. To adopt the revisions to the appointment of political proportionality set out in Table 1.

## 1. BACKGROUND/INTRODUCTION

Each municipal year Council sets out the political proportionality of seats on committees based on the size of each group in accordance with the rules set out in the Local Government and Housing Act 1989 and the supporting regulations.

Following the resignation from the Fenland First Independent Alliance of Councillor Skoulding the group failed to meet the minimum size requirement set out in legislation. Accordingly the proportionality of committees must be reconsidered.

## 2. CONSIDERATIONS

The Council has 40 Councillors of which 39 are aligned to political groups within the meaning of the Local Government and Housing Act 1989 and the supporting regulations.
The Groups are as follows:

| Conservative | 34 | $87 \%$ |

| Truly Independent Group | 2 | $5 \%$ |

It should be noted that political groups can appoint members who are not aligned to a political group, or indeed aligned to another group to seats allocated to them under the political proportionality rules.

A number of committee allocations have changed as a result of this and the details of the revised proportionality allocations are detailed in table 1.
