## 4 Background / introduction

For each municipal year Council has to set out the Committees and Panels which are to be established. On establishing the Committees and Panels in accordance with the rules relating to Political Proportionality the seats on each committee and panel together with the position of Chairman and Vice Chairman to allocated to Political Parties.

## 5 Considerations

The rules relating to political proportionality in relation to membership of committees are set out in the Local Government and Housing act 1989 and the supporting regulations.

For the purposes of the regulations a political group must consist of two or more members who have signed a declaration that effect.

For the purposes of the regulations a political group must consist of two or more members who have signed a declaration to the effect. Where one or more groups exist the relative proportions of the groups should be used in allocating seats on committees.

The distribution of the 39 current members (with 1 seat vacant of the total of 40 seats) of the Council within the group structures is:

| Conservative | 33 | $87 \%$ |
| :--- | :--- | :--- |
| Lib Dem Alliance | 3 | $8 \%$ |
| Truly Independent | 2 | $5 \%$ |
| Unaligned (including 1 vacant seat) | 2 |  |

One seat at Roman Bank is currently vacant and one member is not part of any political grouping and is therefore regarded as unaligned for the purposes of this calculation, however the number of seats on any given committee has not been changed by this situation.

It should be noted that political groups can appoint members who are not aligned to a political group, or indeed aligned to another group to seats allocated to them under the political proportionality rules.

## 6 Committees and Panels

Cabinet is exempt from the requirements of political proportionality, and its membership is determined by the Leader of the Council in accordance with Article 7.

The Table laid out in the appendix to this report sets out the standing committees of the Council and the allocation of the seats to political group.
