- Representations received during the consultations on the proposed submission plan and proposed submission addendum;
- Observations made by officers post Submission;
- Responses by officers to questions raised by the Inspector in her Matters and Issues for Examination; and
- Throughout the Examination hearing sessions held between 9 13 December 2013.


This version lists all the minor modifications which have arisen either through written representations or throughout the examination. It supersedes both previous versions of the schedule (Version (a) (Sept 2013) and Version (b) of the Schedule, dated 22 November 2013. It should be read in conjunction with the schedule of proposed Main Modifications, January 2014.

This updated version for the Full Council meeting on 8<sup>th</sup> May 2014 also includes minor changes to the compiled version of the Local Plan document that was considered by Cabinet on 24<sup>th</sup> April 2014 as Appendix B.

Minor modifications are generally regarded as textual and grammar corrections; re-phrasing or limited new text to add clarity; or updates to figures and references which are necessary due to alterations which have been made elsewhere or for which new information has come to light.

The schedule includes the following information:

Change ID: change identification number for reference. The ID number is composed as so:



**Section of Submission Version:** the section of the Core Strategy to which the change applies. **Policy/ paragraph:** the specific policy or paragraph within the section to which the change applies.

Page: where the applicable policy or paragraph is located in the Submission Plan.

**Proposed change:** details of the proposed amendment. Unless it states otherwise, where text is to be deleted it will have a strikethrough as so: deleted text. Where additional text is proposed, it will be underlined as so: additional text.

**Reason for change:** brief details of why the change is proposed.

**Rep No:** If the change is predominantly due to a request in a representation, then the representation identification number is listed.
