The Electoral Commission has published updated guidance as to the conduct of reviews of polling districts and polling places with respect to the compulsory reviews which must be started and completed between 1st October 2013 and 31st January 2015 by all local authorities with responsibility for electoral arrangements [hereinafter "the Commission's guidance"]. 2. The Commission's guidance lays out the statutory obligations which such a review must adhere to, and also gives guidance as to best practice. 3. Fenland District Council, in conducting this review, should be committed to follow the Commission's guidance with regards to best practice, as well as adhering to the statutory requirements, whilst seeking at the same time to promote efficient and effective local government. 4. I wish to raise objections in respect of three matters: (a) There are, surprisingly, 13 polling districts within the consultation document for which it is proposed that the preferred polling station (or a named alternative polling station) should lie outside the boundary of that polling district. Four of these preferred or alternative polling stations lie outside the District Council ward within which that polling district's electors live. 	The review has been delayed as far as practical due to the Community Governance Review, but is being undertaken to comply with the deadline of the 31 January 2015, with the proposals being considered by the last Council meeting on 18 December 2014 before this deadline. The Community Governance Review proposals have been fully taken into account in the consultation document. The Electoral Commission's document is only guidance, which has been followed as far as possible and practicable. In some instances there are no suitable polling stations within the ward and the nearest suitable polling station within an adjoining ward has been identified and in some instances we have identified new potential polling stations within a ward itself and the reasoning for these suggestions is within the consultation report. The Commission's guidance states (paragraph 2.14) that "A polling place within a polling district must be designated so that polling stations are within easy reach of all electors from across the polling district" and (paragraph 4.1) that "the polling place must be an area in the district, unless special circumstances make it desirable to designate an area wholly or partly outside the district (for example, if no accessible polling place can be identified in the district)" 6. Fenland's consultation document identifies thirteen potential polling stations which lie outside the boundaries of the polling district they would serve. In most cases, these are arrangements which have been in place for some years. Five of these polling districts are affected by the Community Governance Review and I shall deal with those later in this representation. The other eight are as follows: 6(i). March North Ward - the use of St John Church Hall as a dual polling station serving polling district BB2 is proposed as an alternative arrangement. 6(ii). However, it does lie some way outside the polling district and Ward which it is meant to serve, although a single (rather long) road does link many of the electors in the polling district with that polling station. I would ask that consideration be given to the siting of a mobile polling station within the area of the DI polling district. This would clearly improve both accessibility and convenience for electors in that polling district. Mobile polling stations are widely used in other local authority areas around the country specifically to ensure that voters in less urban areas, which have fewer community or other facilities suitable for use as polling stations, are not unfairly disadvantaged so far as the accessibility and convenience of voting is concerned. 10.
