Cambridgeshire Flood and Water Supplementary Planning Document

Adoption Statement

Notice is hereby given, in accordance with Regulations 11 and 14 of the Town and Country Planning (Local Planning) (England) Regulations 2012, that Fenland District Council adopted the Cambridgeshire Flood and Water Supplementary Planning Document (SPD) under the provisions of Section 23 of the Planning and Compulsory Purchase Act 2004 on 15 December 2016.

The Cambridgeshire Flood and Water SPD has been prepared by Cambridgeshire County Council as the Lead Local Flood Authority in partnership with Cambridge City Council, East Cambridgeshire District Council, Fenland District Council, Huntingdonshire District Council, South Cambridgeshire District Council, the Environment Agency, Anglian Water and Internal Drainage Boards.

The SPD provides guidance for developers and applicants on managing flood risk and the water environment in and around new developments. The contents of the SPD expand upon the flood risk and water management policies contained within the adopted and emerging Local Plans.

The adopted version of the Cambridgeshire Flood and Water SPD includes modifications made by Cambridgeshire County Council (in conjunction with partners) in the light of representations and other minor changes which, taken together, do not materially affect the guidance. All the modifications made since the publication of the draft version of the SPD (September 2015) are included in the Consultation Statement report.
