Council Tax 2019/20

Following consideration of the report to this Council on 21 February 2019 and the setting of the Revenue Budget for 2019/20, the Council is required to pass the resolution below to set the Council Tax requirement.

RESOLVED

- (1) it be noted that the Tax Base for the year 2019/20 has been calculated in accordance with the Local Government Finance Act 1992 and associated regulations as follows:
 - (a) 29,380 being the amount calculated by the Council as its Council Tax Base for the year, in accordance with regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 (as amended).
 - (b) Part of the Council's area

 - (c) £9,015,869 being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year [Net Expenditure, including Parish Precepts]
 - (d) £306.87 being the amount at 3(c) above divided by the Council Tax Base at 1(b) above, in accordance with Section 31B(1) of the Act, [basic amount of its Council Tax for the year, including Parish precepts]
 - (e) £1,363,559 being the aggregate amount of all special items referred to in Section 35(1) of the Act **[Parish Precepts]**
 - (f) £260.46 being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by the amount at (1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no special item relates
