The above payments have been made in accordance with the Council's Members' Allowances Scheme that came into effect, as a result of a review undertaken by an Independent Remuneration Panel on 4 May 2021. The revised scheme was introduced on 1 April 2021. The new allowances for 2023/24 are detailed in the table below. A copy of the current scheme is available from the address below and on the Council's website (contained at Part 6 of the Constitution) at <a href="https://www.fenland.gov.uk">www.fenland.gov.uk</a>.

The scheme provides for a Basic Allowance that is payable equally to all members (of £5,044 in 2022/23 and £5,044 in 2023/24) and Special Responsibility Allowances (SRAs) payable to the holders of certain positions within the Council, subject to an Independent Remuneration Panel review of the 2022/23 pay award, which may result in these amounts increasing and being backdated to April 2022, and an increase in line with any subsequent employee pay award. Listed below are the posts that currently attract SRAs together with the respective level of allowances payable in 2022/23 and the current corresponding allowances for 2023/24.
