

To Enter

1. The Schools Competition 'Inspector Blue Mysteries' (the "Competition") is open to children living in Fenland and aged between 5 and 11 years old ("You"). Sending in an entry to the Competition means that You accept these Terms and Conditions.
2. You must have consent in writing (which may include e-mail) of the parent/ guardian or teacher of the winning entrant to be published that winning entry and the author's name, age and school on www.fenland.gov.uk, via social media, press release and other promotional medias. If FDC does not receive written this consent then we may award the prize to another entrant for which we are able to gain such consent.
3. To enter the Competition, You should complete the 'Culprit' entry form or submit your own video/poster or idea. Templates are available on the Council's website and via local schools.
4. To enter the Competition you should return the form to your school (where participating) or send your entry to "Getting it Sorted, Fenland District Council, March, Cambridgeshire PE15 0EN" or email to gettingitsorted@fenland.gov.uk You must ensure that you complete the second side of the templates with your name, the name of the Fenland school that You attend, class and Your age. We will only use this information in relation to the Competition (including checking your eligibility to enter it and so that we can contact winners to arrange their prizes) and will not use it for any other purposes whatsoever. We will not keep this information for longer than is necessary for the operation of the Competition.
5. You may submit a maximum of two entries to the Competition.
6. We must receive your entry to the Competition by 11:59 pm on Friday 31st March 2023.
7. Entries on behalf of another person will not be accepted. We take no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any reason. Proof of delivery of the entry is not proof of receipt. FDC shall not be liable for any failure to comply with its obligations caused by something outside reasonable control.
8. You are responsible for the cost of sending your Competition entry to us. Your entry will not be returned to You.

Picking the winners and publishing entries

9. The relevant FDC portfolio holder will pick 1 WINNER from a shortlist of UP TO 20 chosen by the Head of Environmental Services or their representative. The winning entry will be the one from the shortlist that the portfolio holder considers to be the most original, creative and well-executed. The portfolio holder's decision will be made in April 2023 The decision is final and no correspondence will be entered into.
10. The names of the winners will be published on the Fenland District Council website from April 2023.
11. By submitting an entry to the Competition, You give FDC copyright of the entry and: a) the right to published the entry on any FDC promotional medias with unlimited usage and without charge; and b) The right to use your name, age and school for the sole purpose of identifying You as the author of your entry.

The Prizes

12. The chosen winner will receive an art set. We will substitute the prize with another prize of similar value in the event that the original prize offered is unavailable. The school of the winner will be notified by telephone or email after 31st March 2023 and will be required to contact the parent or guardian of the winner to provide consent. The prize will be sent to the winner by FDC by May 2023. The prizes cannot be transferred by You and cannot be redeemed by You for cash or any other prizes.
13. The school that the winning student attends will be offered the opportunity to take up a free collection of their mixed dry recycling materials for the period of 1 year. This is up to a maximum cost of £660. This offer will need to be accepted by 31st April 2023 and will involve the usual contract and terms for waste collection where the school does not already receive this service from the Council. No alternatives, extensions or cash equivalent will be available. The school must be within the district boundary of Fenland.

Other rules
