Title of the document which the Council proposes to submit to the Secretary of State:	Fenland Core Strategy Development Plan Document (DPD)
Subject matter and area covered:	The Core Strategy sets out the Council's vision, objectives, spatial strategy and core policies for the future development of Fenland, together with strategic allocations of land for development and the identification of broad locations for growth. It applies to the whole of the administrative area of Fenland District Council. It is accompanied by a submission Policies Map.
Period for representations:	Representations on the document may be made between 9am on 28 February and 5pm on 10 April 2013.
